#### **AGREEMENT**

On cooperation and joint activities between

## Herzog Academic College,

Jerusalem and Alon-Shvut, Israel

# And the Private Institution "Beit Chana International Humanitarian and Pedagogical Institute"

Dnepr, Ukraine Hereinafter: **The 'Parties'** 

This Agreement on cooperation and joint activities is entered into by and between Herzog College in Israel (hereinafter the "College"), and the Private Institution: "Beit Chana International Humanitarian and Pedagogical Institute" (hereinafter referred to as "The Institute"), represented by the Rector Rima Semenovna Aronova, acting on the basis of the Charter of the Institute.

#### I. General provisions

- 1.1. The subject of the Agreement is the cooperation and joint activities of the College and the Institute in the implementation of educational, scientific and other activities not prohibited by the laws of Ukraine and Israel, activities in the field of training, retraining and advanced training of specialists in the field of Education/Pedagogy and Social and Behavioral Sciences.
- 1.2. The implementation of the measures provided for by this agreement is carried out in accordance with the legislation and regulatory documents stipulating the activities of higher education institutions in Ukraine and Israel.
- 1.3. This agreement does not affect the obligations of the Parties under their contractual relations with other legal entities and individuals.
- 1.4. All issues, problems and disagreements that arise in the process of teamwork and cooperation, the Parties undertake to resolve through constructive negotiations, taking into account the interests of each party and the goals provided for in this agreement.

#### II. Main areas of cooperation between the Parties

- **2.1.** As part of the cooperation, the Parties agree to implement the following activities in areas of joint activity:
  - 2.1. A. Educational and educational-methodological work
  - conduct joint methodological seminars, consultations, etc.;
  - develop and implement joint educational projects.
  - 2.1. B Scientific research
  - hold joint scientific and practical conferences.

## III. Duties of the parties

#### The College undertakes:

- to inform the Institute about the possibility of participation of Institute teachers in scientific events and trainings held at the College;
- to create joint educational projects for students of the Institute

#### The Institute undertakes:

- to promote participation in joint educational projects with students of the Institute.
- Coordinate with the College the course syllabuses of joint educational projects.

## IV. Duration and procedure for termination of the contract

- **4.1.** The agreement acquires legal force from the date of its signing by the College and the Institute and is valid for three years.
- **4.2.** Changes and additions to the Agreement are accepted by agreement of both Parties and enacted by signing additional agreements, which are an integral part of this agreement.
- **4.3.** If one of the Parties fails to fulfill its obligations under this agreement or additional agreements to it, the agreement can be dismissed either by agreement of the Parties, or separately.
- **4.4.** Unagreed issues related to the implementation of the provisions of this agreement will be considered in accordance with the current legislation of Ukraine and Israel.
